On September 30, 2006, the first one-third tranche of Restricted Share Units vested and 1,333 shares of common stock were issued to the Reporting Person.
- 414 shares of common stock were withheld from the issuance of common stock to Reporting Person upon vesting of Restricted Share Units, in order to satisfy the Reporting Person's obligations for payment of withholding and other taxes due in connection therewith.
- Each Restricted Share Unit represents a contingent right to receive one share of common stock.
